# COLUSA COUNTY FAIR 2014 MR. CINDERFELLA PAGEANT

The Mr. Cinderfella Pageant provides an opportunity to enhance your personal development in the areas of poise (in heels?), self-confidence (to do what?), communication skills (if your voice doesn't crack), and good sportsmanship (what kind of sport is it without a ball?) . . All rules and regulations are designed to make the pageant a fun and successful event for all involved (the audience at least).

The winner will designate the High School Club or Organization (must be recognized by the school) to which \$1,500 will be donated in his name. He will also receive other assorted items related to his title.  $1^{st}$  Runner up's designated High School Club or Organization will receive \$500.

### GENERAL REQUIREMENTS

- 1. Contestant must be incoming Sophomore, Junior, Senior or Grad at one of the 5 High Schools in Colusa County.
- Contestant must agree to abide by all the rules and regulations of the Mr. Cinderfella Pageant and Fair Board rules and regulations. Failure to do so may result in disqualification.
- 3. Mr. Cinderfella Pageant contestants, if not chosen as the winner, may compete in following years.

#### APPLICATION DEADLINE

- 4. Contestant must complete the official pageant application.
- 5. Parent or legal guardian must sign applications if applicant is under the age of 18.
- 6. All applications must be in the Colusa County Fair Office no later than 4:00 p.m. on Monday, April 28, 2014, or be postmarked by that date.
- 7. Applications are limited to the first 15 entries and 3 entries per school.
- 8. The application must designate the High School club or organization to which the prize money will be given if the applicant wins.

#### SPONSORS AND APPLICATION

- 9. Contestant and/or sponsors shall pay an application fee of \$20.14 per contestant. Checks are to be made payable to the Colusa County Fair.
- 10. Sponsors will be announced on stage during the contestant's various areas of competition (if they really want to have their name announced in this situation).
- 11. Application Fee must accompany the contestant's application.
- 12. Contestant applications that are not completed properly or accompanied by the application fee will not be accepted or processed.
- 13. Any sponsorship monies collected <u>above the minimum</u> fee will be held by the Fair for the contestant as a scholarship until enrollment in college or accredited vocational school at which time the monies will be sent to that school or college's *financial aid and scholarship office* for distribution to the contestant.

#### COMPETITION ACTIVITIES

- 14. Each contestant must perform one lip-syncing musical act and provide the music on a CD to the Pageant Directors who will have final determination of the suitability of the routine. Duplicate songs will not be permitted; if more than one contestant proposes the same song, the contestant with the latest entry submission will have to select another song. Reminder: Contestants will be judged on the level of knowing the song throughout the lip sync, as well as the performance and their onstage interview response.
- 15. Contestant agrees to attend all (at least 3) rehearsals which will be scheduled after entries close.
- 16. Each contestant is allowed 1 "fairy godmother" back stage (must be a student at the contestant's High School) for getting them ready "to go to the pageant"; (Backstage is a Parent Free Zone).
- 17. Scoring criteria will be based on individual talent, on stage interview and poise, divided equally into a third of the points.
- 18. Contestant understands that this activity is a comedic entertainment event.

#### LOST ARTICLES

19. Contestants understand that the competition management will not be responsible for lost or stolen articles during any pre-competition and/or competition activities.
